Biographical/Historical Note

These documents came from the estate of Dr. Benjamin Walworth, given to the museum by his daughter Rebecca Walworth Forbes in 1902. Rebecca was the wife of Mr. Elias Forbes. Dr. Benjamin Walworth was a practicing physician, served as Chautauqua County Judge for several decades, and was a leading citizen of Fredonia, NY. Elias Forbes was the principal owner and manager of Fredonia Gas Works. There are also documents belonging to Philo and Abiram Orton in the collection. The connection to Walworth could be professional, as Philo Orton worked as an associate to Judge Zattu Cushing before becoming an associate judge of the county.

Scope and Content

This collection is comprised of deeds, land indentures, estate papers, personal and professional correspondence, financial documents, insurance documents, and patent papers belonging to Philo Orton, Abiram Orton, Benjamin Walworth, and Elias Forbes.

Arrangement

The collection has been grouped into thirteen folders, honoring the original order in which the documents were found. Items within each folder have been arranged chronologically.
